Venue Hire

When comparing our prices with other venues please remember we do not take full wedding bookings on consecutive days. Our pricing reflects the fact that you will have access to our facilities from the afternoon before the wedding, until late morning on the following day – after a leisurely breakfast perhaps!

Civil Ceremony -Only

Our Lake side wedding suite is licensed for Civil Ceremonies. We provide seating for 60 people in a carpeted private room – Intimate and Romantic!

You will need to arrange your own registrar by calling Wellingborough Registry Office on 01933 231 549 to confirm they have the date and time available. Once the date is confirmed by the registrar, a non-refundable deposit payment of £100-00 should be paid to Bevington Inns Ltd to confirm the ceremony. Final Payment of the balance must be made 4 weeks prior to the date of the wedding .Dates can be booked up to 12 months in advance. Charges made by the registrar are completely separate from Charges made by Grendon Lakes.

Due to the nature of the ceremony, guests are reminded that no food or drink can be taken into the wedding suite, and photographs and videos of the event should be arranged with the registrar prior to the day The ceremony itself takes approximately 15 minutes. However, the bride and groom will be required to meet the Registrar 30 minutes prior to the service either together or separately according to their own wishes. According to legal formalities a religious blessing may not take place at the same time as the civil ceremony and similarly there must not be any religious symbols in the room

Finally all music must be approved by the Register Office.

Decorations

You are able to decorate the venue as much or a little as you desire. Fairy Lights, candles, table confetti etc can all add that special touch to your day/night. Our Staff can complete the decorations for you on the day of the wedding at a cost of £100.00

Camping

An added benefit of Grendon Lakes is our Campsite, Just a few minute walk from the venue. All of your guests are able to book a pitch for the night, or alternatively you can hire our private VIP camping village, which is separate from the main camping areas and can accommodate 150 people. This is accessible from the venue via a foot bridge. The VIP camping village has a purpose built fire pit with seating. All wedding couples who hire the Camping village are treated to a complimentary night in our very own Glamping Tent.

Terms and Conditions

Confirmation of Booking

A signed copy of these terms and conditions or written confirmation of the booking from the customer, receipt of which shall be deemed by Grendon Lakes (Bevington Inns Ltd) as the customers acceptance of these terms and conditions.

Deposits and Prepayments

All bookings will be provisional and held for a maximum of 7 days until a non-refundable deposit of £500.00 for catered weddings, £100.00 for Civil Ceremony only, £250.00 for Evening Room hire is received by Grendon Lakes (Bevington Inns Ltd) and a receipt is issued to the customer. If no deposit is received Grendon Lakes (Bevington Inns Ltd) reserve the right to release the booking.

6 weeks prior to the event a further 50% of the estimated final account is to be paid

14 days prior to the event the remaining outstanding balance must be settled.

All Cheques must be made payable to Bevington Inns Ltd

Cancellation by the Customer

In the event of cancellation/postponement by the customer, this must be made in writing: cancellation fees will be based on the minimum numbers and estimated total cost of the event.

In excess of 12 weeks prior to the event date Grendon Lakes (Bevington Inns Ltd) shall retain the non-refundable deposit.

If cancelled 2-6 weeks prior to the event 50% of the total amount determined by minimum numbers

If cancelled less than 2 weeks prior to the event, 100% of the total amount, determined by minimum numbers is payable.

Changes in number of guests

Provisional numbers will be required at booking. Grendon Lakes (Bevington Inns Ltd) minimum charges will be based on these figures

No later than 28 days prior to the event, the customer shall provide Grendon Lakes (Bevington Inns Ltd) with an update on numbers

No later than 14 days prior to the event the customer and Grendon Lakes (Bevington Inns Ltd) shall agree final numbers. This figure will then form the calculation for the final charges. Should these figures reduce within 14 days prior to the event Grendon Lakes (Bevington Inns Ltd) reserves the right to charge 50% of the charge per head for non-attending guests.

Payment

If payment is made by credit card a 4% charge will be added

If cheques are returned unpaid a charge of £35 per cheque will be added

If a deposit has been taken and no cancellation charge is due the deposit will be refunded in full.

Cancellation by Grendon Lakes (Bevington Inns Ltd)

In the event of cancellation by Grendon Lakes (Bevington Inns Ltd) will refund any advance payments made, but will have no further liability to the customer.

Grendon Lakes may cancel the booking

- If the venue is closed whole or in part due to fire, employee disputes, alteration, decoration or by order of any public authority*
- If the Customer fail to adhere to any of the Terms and Conditions*
- If in the Opinion of the management it might prejudice the reputation of Grendon Lakes (Bevington Inns Ltd)*
- If full payment is not received before the event*

Liability and Insurance

Grendon Lakes (Bevington Inns Ltd) will not be liable to the customer or their guests for loss or damage to property except and to the extent that any such loss or damage is caused directly and wholly by the negligence of Grendon Lakes (Bevington Inns Ltd) or its employees All clothing, personal property or other goods left by the customer and guests will be left at their own risk,

Should Grendon Lakes (Bevington Inns Ltd) agree to the customer employing the services of any outside contractor, other than those arranged by Grendon Lakes (Bevington Inns Ltd), the customer shall indemnify Grendon Lakes (Bevington Inns Ltd) against any claims made against Grendon Lakes (Bevington Inns Ltd) resulting from an act or default by any such contractor, his staff or agents or caused by equipment supplied by them or others. This indemnity is also to include cover under the Health and Safety at Work Act 1974 and Environmental Health . Any outside contractor employed by the customer, must report to the Manager and contractors must comply with appropriate legislation including Fire Precautions Act. Grendon Lakes (Bevington Inns Ltd) reserves the right to refuse access without prejudice to any contractor.

Customer Obligations

The customer shall:

- Ensure all persons attending the function do not commit any nuisance, disturbance or infringement which may jeopardise the licenses of Grendon Lakes (Bevington Inns Ltd). All guest must comply with the reasonable requests of Grendon Lakes Staff. All Members of Staff are representatives of Bevington Inns Ltd and its owners, all complaints must be directed to a member of the management.*
- Not bring to or consume any food or beverages on the premises other than those supplied by Grendon Lakes (Bevington Inns Ltd), excluding Wedding/Birthday Cakes.*
- Ensure that all guests are aware that Grendon Lakes operates a strict policy on underage drinking. We can and will request identification of all those who we suspect are under 21 years of age.*
- Ensure that all guests camping within the V.I.P camping area as part of a wedding package, register at the clubhouse before pitching and follow all Grendon lakes campsite rules and separate booking terms and conditions.*
- Unless agreement has been made with Grendon Lakes (Bevington Inns Ltd) and payment of £100.00 is received by Grendon Lakes (Bevington Inns Ltd) prior to the vent. The customer must organise for someone to come into the venue to complete decoration such as balloons, table decoration and outside decorations, this list is not exhaustive. Failure to arrange this may result in decorations being incomplete.*

Jurisdiction
